- We organize not-for-profit corporations and unincorporated entities for state law purposes, including drafting incorporation documentation, bylaws and policies, conflict of interest policies, document retention policies and whistleblower policies.

We provide advice on compensating directors, officers and executives under the Internal Revenue Service guidelines. We draft licensing agreements, employment and independent contractor agreements.
